

**ORDINANCE NO. 18-O-06**

**ORDINANCE AMENDING CHAPTER 15.52, ENERGY CONSERVATION CODE,  
OF THE VILLAGE CODE**

**WHEREAS**, the Village of Round Lake (the "Village") is a non-home rule municipality organized and exercising such powers granted under the Constitution and laws of the State of Illinois; and

**WHEREAS**, the Village President and Board of Trustee desire to amend the Village Code to adopt the 2015 International Energy Conservation Code; and

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROUND LAKE, LAKE COUNTY, ILLINOIS, as follows:**

**SECTION ONE:** That Sections 15.52.010 and 15.52.020, of the Round Lake Village Code, as amended, is hereby further amended with subtractions in strikethrough text and additions in bold underlined text, so that the same shall be read as follows:

15.52.010 - International Energy Conservation Code, ~~2009 Edition~~, adopted.

The ~~2009~~ **most recent adopted edition of the** International Energy Conservation Code, and subsequent amendments thereto shall be and the same is hereby adopted by reference as Energy Conservation Code of the Village of Round Lake, as if fully set forth herein, three copies of which shall be kept on file with the village clerk. 15.52.020 - Amendments and revisions.

The following sections of the International Energy Conservation Code, ~~2009 Edition~~, are amended and revised as hereinafter stated:

"Village of Round Lake" shall be inserted wherever the words "name of jurisdiction" appears.

~~Section 107.2 is hereby amended in its entirety as follows: The fees for any permit associated with any energy conservation work, as required by this code, shall be as indicated by the Village Code of Round Lake.~~

~~Section 108.4~~ Insert the number "\$50" and "\$750" respectively where the words "AMOUNT" appear."

All references to the International Plumbing Code shall be deleted and replaced with the Illinois Plumbing Code. (Ord. 06-O-67 § 1 (part)) (Ord. No. 10-O-31, § 1, 7-19-2010)

**SECTION TWO:** That the Village Clerk is directed hereby to publish this Ordinance in pamphlet form, pursuant to the Statutes of the State of Illinois.

**SECTION THREE:** That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
